Annual Report of Legal Aid Clinic-2018-19

Legal Aid Clinic of S.S. Maniyar Law College is providing free legal aid to poor, weak and the marginalized sections of the society for establishing their Constitutional and legal rights. The aim of the Legal Literacy programmes is to create the legal awareness amongst the people. At the same time, the budding lawyer should know their social responsibility. It provides platform to the law students to be societal oriented. The Legal Aid Clinic is bound to fulfill the Constitutional mandate, which is enshrined in preamble, Article-14, Article-21 and Article-39A of the Constitution.

Every year college conducts Legal Literacy Programmes in the rural and urban areas of the Jalgaon district. The special feature of this camp is that the students are performing 'Pathnatya' (Street Play) and creating legal awareness among people. The Judicial officers are also participating in the camp and addressing the people. Every year students are visit the Jail, creates awareness to the prisoners about their rights, and contributes for the speedy trial of under trial prisoners. The students work as a Para legal volunteers and provide the free legal aid to the people. They are doing surveys in slum area as well as provided free legal aid to them.

This year, on 22.09.2018, Legal Aid Clinic organized inauguration programme of Legal-Aid Cell. In the presence of Smt. Jayshree Patil, Superintendent of Child Care and Protection Home, Jalgaon was present and guided to the students.


On 13.10.2018, District Legal Services Authorities, Jalgaon had organized the Legal Awareness Programme at Varud village in Jalgaon district. Dr. Vijeta Singh and final year students were participated in this camp. Students were performed street plays on different socio-legal issues.

Legal Aid Clinic of the college with collaboration of District Legal Services Authority organized one day Legal Aid Camp on 07.04.2019 at Tarsod Village in Taluka and District Jalgaon with a view to create awareness amongst the rural people. The programme was

inaugurated by Mr. K.H.Thombre, Hon'ble Secy, Dist. Legal Services Authorities, Jalgaon and presided over by Principal Dr.B.Yuvakumar Reddy, Hon'ble Mr. B.D. Gore, Judicial Magistrate First Class, Jalgaon, Hon'ble Mr.D.B. Sathe Judicial Magistrate First class, Block Development officer shriSonwane, Gramsevakshri Narendra Salunkhe, Sarpanchshri Pankaj Patil, faculties of the college Prof. D.R.Kshirsagar, Prof. Y.A.Mahajan, Prof. G.V.Dhumale, Dr.Vijeta Singh, Dr R.P. Pahuja and Prof. Anjali Bondar were present for programme.

Mr. K.H.Thombre enlightened on various schemes and asked the villagers to approach the District Legal Service Authorities to get free legal-aid. Hon'ble Mr.B.D.Gore had emphasized on importance of free legal services and benefits of Alternative Dispute Resolution system. The students of final year class were enlightened on various socio-legal problems including importance of Swachhta Aabhiyan, role of Legal Services Authorities in free legal aid and Women empowerment etc. Students were also performed Pathnatya on different socio-legal issues including domestic violence, corruption, women empowerment, prohibition of liquor, importance of female education etc. Through speeches and 'Pathnatyas' students were created awareness amongst villagers. The programme was compared by Prashant Kshtriya and vote of thanks was proposed by Secretary Asst.Prof.Anjali Bondar.
